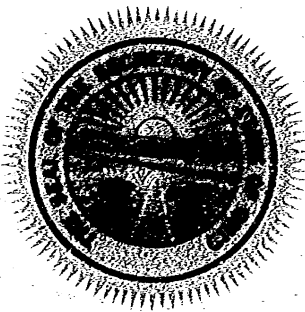

ARTICLES OF INCORPORATION  
OF

The undersigned, desiring to form a corporation, for profit, under Sections 1701.01 et seq. of the Revised Code of Ohio, do hereby certify:

FIRST: The name of said corporation shall be:

Starlite Triple T Roller Rink, Co.

SECOND: The place in Ohio where its principal office is to be located is:

120 Commerce Drive  
LaGrange, Ohio 44050  
Lorain County

THIRD: The purpose for which said corporation is formed is the operating and conducting of a roller rink business, and doing any and all things necessary or incidental thereto and to engage in any lawful act or activity for which corporations may be formed under Revised Code Sections 1701.01 to 1701.98 inclusive.

FOURTH: The number of shares which the corporation is authorized to issue is 750 shares, all of which shall be common shares, without par value.

FIFTH: If and when any shareholder desires, or on the happening of any event, is required to sell his shares, or any part thereof, said corporation shall have a pre-emptive

right to purchase the same, at the book value at such time, for the purpose of resale to shareholders or others his shares, or any part thereof, shall give to said corporation written notice of such desire or requirement to sell, and if the exercise of such pre-emptive right be authorized by the Board of Directors, such right shall be exercised by said corporation within thirty (30) days after receipt of such notice, but if not so exercised, such pre-emptive right shall be null and void after the expiration of said thirty (30) days.




